Summary

Over the course of four years, Ross Cline (柯受恩) endured a systematic series of judicial abuses culminating in forced exile from Taiwan despite having committed no criminal act. The Taiwan judicial authorities denied him access to basic legal protections, ignored key defense evidence, imposed arbitrary punishments, and forced him into a legal nightmare that destroyed his business, reputation, and emotional well-being. Even after fleeing to Canada, bureaucratic harassment persisted until international exposure efforts finally forced Taiwan's prosecutors to abruptly "close" the case without apology or redress. The trauma and damages inflicted over these years are severe, ongoing, and demand urgent corrective action, acknowledgment, and fair compensation.

概述段落

在這四年期間,柯受恩遭遇系繫性的反權審討失靈,最終被強迫逃離臺灣,卻並未置事件有效處理。臺灣司法機關在未任何合理證據下,拒絕認錯,違反訴訟權利和正當法律義務,導致商業破產,名譽損失,情感傷痛。目前,相關機關必須將此案上區於公民權利與國際人權標準下,認真處理,給予有效適當的道歉與補償。
