



## Full Case Statement – Ross Cline | 案件說明函

敬啟者：

我是柯受恩（Ross Cline），一位加拿大籍教育者，自 2009 年起於台灣生活與任教，共十五年。期間我建立了語言教學事業，繳納稅賦、貢獻地方社區，與台灣有深厚連結。然於 2024 年底，我被迫離境返國，並非因個人意願，而是因台灣司法系統中之程序失當、選擇性執法與對外國人士的制度性偏見所致。



### 事件簡要：

**1. 案件來源為一份租約：**

2019 年，因房東故意破壞捲門導致極大危險（該門於維修隔日倒塌），我出於恐懼與自保，將租約（包含房東姓名、電郵、生日與身分證字號）公開於社群媒體三日。

**2. 三件刑事訴訟，未合併處理：**

三件訴訟皆為「違反個資法」，法官未依法合併案件，反而個別處理，加重我刑事風險與壓力。

**3. 證據全被忽略：**

五位願意出庭作證之本地證人未被法院傳喚；TVBS 播出的影片證據亦未納入考量。本人無律師陪同、亦未獲翻譯協助。

**4. 刑期加重原因為「無悔意」：**

原判兩個月刑期，僅因未表達「悔意」即升至六個月。

**5. 最終選擇離境：**

在短暫諮詢律師後，明確建議我立即出境以避免收押。自此我被迫滯留加拿大，生活全毀，並持續收到法院與檢方來信。



### 更進一步：

此案件已引起加拿大媒體關注。本人接受了 CHCO-TV 採訪，該節目將於 2025 年 4 月 25 日播出，提供中文字幕版本。相關事證與影片已公開整理，網址如下：

本人並未尋求報復，而是追求制度責任與人權保障。我呼籲相關單位正視此案，並針對程序正義與刑事合併原則進行檢討，以免更多外籍人士遭遇相同命運。

Dear Sir or Madam,

My name is Ross Cline, a Canadian educator who lived in Taiwan for 15 years, from 2009 to 2024. I taught English, ran a language consulting business, paid taxes, and deeply contributed to the local community. In late 2024, I was forced to leave Taiwan — not by choice, but due to unjust judicial processes, selective enforcement, and systemic bias against foreign nationals.

### **Case Summary:**

**1. The case began with a rental contract:**

In 2019, my landlord's agent allegedly sabotaged a rolling gate, which collapsed the next day, nearly causing serious harm. In fear and distress, I publicly shared my lease contract (containing the landlord's name, ID number, email, and birthday) for three days on social media.

**2. Three criminal charges filed separately:**

Instead of consolidating the three criminal cases (as is standard legal practice), the court processed them separately, significantly increasing my legal exposure and risk.

**3. All evidence ignored:**

Five Taiwanese witnesses were never called to testify. Video evidence of the collapsing gate, aired by national broadcaster TVBS, was dismissed. I had no legal representation, no interpreter, and no opportunity for a proper defense.

**4. Sentence extended for 'lack of remorse':**

My original sentence was two months. It was extended to six months simply because the judge felt I had not shown enough "remorse."

**5. Forced departure:**

After a brief consultation with a lawyer, I was advised to leave the country immediately to avoid incarceration. Since then, I have been in exile in New Brunswick, Canada. My life was upended. I continue to receive court notices to this day.

### **What Now:**

This case has been picked up by Canadian media. I was interviewed by CHCO-TV and the segment will air on April 25, 2025, with Chinese subtitles. Full documentation and supporting video evidence are available at:

I am not seeking revenge — I am seeking truth, accountability, and policy reform. I urge the relevant bodies in Taiwan to take this case seriously, investigate the abuse of procedure, and prevent this from happening to any other foreign national again.

#### **Canadian Educator Speaks Out on CHCO-TV After Being Forced to Flee Taiwan Due to Alleged Judicial Corruption and Human Rights Violations**

*New Brunswick, Canada – April 25, 2025* — After 15 years of living and working in Taiwan as an English educator and entrepreneur, Ross Cline has returned to Canada under duress, forced to abandon his life due to what he describes as “a broken and biased legal system.”

In a candid and emotional interview with Vicky Hogarth on CHCO-TV, Cline shares the disturbing details of his case — including the Taiwanese court's dismissal of five witnesses and video evidence aired on national news. “This wasn’t just incompetence,” Cline says. “It smelled of either corruption, bribery, or systemic racism.”

The interview sheds light on a pattern of judicial bias and selective enforcement of laws that left Cline vulnerable and voiceless. “You can’t change China from the inside out,” he says. “You have to change China — and Taiwan’s judicial silence on such abuses — from the outside in.”

Now back in New Brunswick, Cline hopes that by telling his story publicly and with subtitled versions of the broadcast shared in Taiwan, justice might finally find its way back to the table.

### **SUBTITLE-READY STATEMENT:**

“I lived in Taiwan for 15 years. I loved my life there, but I was forced to leave because the judicial system ignored key evidence — including five witnesses and video footage that was on national news. I believe this wasn’t a mistake. It was either bribery, corruption, or racism — and I lean toward bribery. Taiwan has so much potential, but when justice is selectively enforced, no one is truly safe. I’m telling my story now, not because I want revenge, but because I want change — and I believe the only way to change these systems is from the outside in.”

I kindly ask that it be escalated to the appropriate channels.

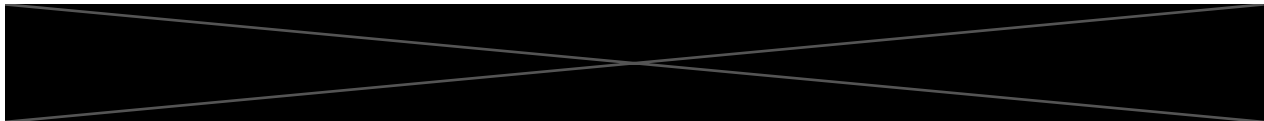
